Dear Friends and Supporters,

The North Yellowstone Education Foundation (NYEF) has surmounted two remarkable 'firsts,' in 2021. We completed the year with our first, salaried, year-round employee, and we started providing the first dedicated, affordable housing for teachers in Gardiner. During this calendar year, NYEF further bolstered its approach and action in each of our three area-specific initiatives: classroom grants, teacher housing, and mental health and wellness programming.

NYEF's first Executive Director, Shelly Siedlaczek, guided the organization into a period of greater vision and capacity. Thanks to Shelly's dedication, we were able to complete a \$300,000 property renovation and enter into the status of landlord—just in time to house three young teachers for the autumn semester at Gardiner Public Schools! Through our partnership with Park County Rural Schools (PCRS360), a county-wide behavioral analyst served 40 students and families in 2021, and we supported over \$20,000 in classroom grants. All of our milestones were made possible by more than doubling our fundraising goals from the year prior.

The work that NYEF is doing is absolutely essential for the long term sustainability of our children's education. NYEF works to uphold the Gardiner K-12 school as the unifying pulse of our community. At the doorstep to the world's first national park, we take great pride in facilitating top-tier education in a way that honors the uniqueness of this place and its people. I would personally like to thank our dedicated board for guiding the organization and for the continued support, and for so many of you in our community of parents, educators, school staff, as well as our in-kind and financial supporters from at home and afar. We could not be at this stage in our development without you. More great things are to come in 2022!

Teacher Housing Initiative

Affordable housing for GPS teachers and staff


A lack of affordable housing is the biggest problem facing Gardiner, Montana today. At the time of this writing, there are two houses for sale in Gardiner: a 4-bedroom home for \$950,000 and a small 2-bedroom for \$640,000. There are almost no long-term rentals to speak of, while the number of short-term vacation rentals continues to grow. This has disproportionately impacted our school.

A starting teacher's salary at Gardiner Public Schools (GPS) is \$35,700. At this rate, no school teacher can afford to live in Gardiner, making it impossible for GPS to hire and retain staff.

If we do not have a high quality school, we will not attract qualified professionals to staff Yellowstone National Park, the Custer-Gallatin National Forest, Yellowstone Forever, Xanterra, and many other businesses. If we do not have enough teachers, we will not have a school.



NYEF is thrilled to provide housing to three GPS teachers!



In order to mitigate this crisis, NYEF launched our *Teacher Housing Initiative*. In 2020, NYEF purchased a historic property in Gardiner that had been used for short-term rentals.

In 2021, we completed \$300,000 in renovations and paid down ½ of the loan (\$165,000).

By providing affordable housing to teachers, we are reinforcing the stability of our school, setting a positive example for the entire community, and restoring Gardiner to its roots.

Phase I of the *Teacher Housing Initiative* is to **complete the acquisition of this property by 2023**. Phase II of the Teacher Housing Initiative will be to invest in **three more affordable units for teachers by 2027.**

Mental & Behavioral Health

North Yellowstone Education Foundation is the fiscal sponsor for Park County Rural Schools 360 (PCRS360). PCRS360 works to provide behavioral and mental health resources, assistance, programming, and accessibility to students, staff, and families in Park County Rural Schools.

PCRS360 employs a full-time behavioral analyst named Bridget Kelly. Across 2021, Bridget worked with more than 40 students and families to meet the mental health needs of our community. PCRS360 also provides support to teachers and staff in the form of meals, gift cards, and "self-care" days, as well as yoga for Gardiner elementary students.

In the fall of 2021, PCRS360 began collaborating with Montana State University to bring a counseling intern into the fold. This will enable more students, staff, and families to receive the mental and behavioral health care they need.




